## CASE STUDY

### The Client's Challenge

They had been involved with a fake agent who processed their permanent residence application using incorrect information and fake documentation. This resulted to their being banned for 5 years in the United States, and also affected their Canadian Permanent Residence application.

They had applied repeatedly and all their applications had been automatically rejected. They had no idea how to go about summounting this challenge. Not until one of our clients referred them to Zirconia Agency, to give us a try.

### Our Solution Processes & Methodology

We have a procedure through which we are able to better provide results. This processes were engaged in solving this particular client's challenges.

**Step 1. Consultation:** Our US immigration attorney had a one-on-one session with the client, to better understand their case, evaluate documents provided, and recommended appealing the visa-ban decision, directly in the USA. Which the client accepted to give it a try.

**Step 2. Retainer:** They paid our retainer fees, we started their appeal process, and they our attorneys were able to help them reduce the 5 years ban tenure to 1 year. This process took 11 months to get tangible results, and enabled them to proceed with Canada PR Application.

**Step 3. Eligibility Assessment:** Our Immigration consultant handled their assessment for prospective PR and Work Permit applicatio in Canada, and within 13 months, we were able to help them secure a Job Offer in Canada through the Atlantic Immigration Pilot Program (AIPP), and today, they are now residents living legally in Canada. They have also visited the United States from Canada.



# IMMIGRATION RESOURCES

Find answers to Frequently Asked Questions (FAQs) about Immigration that most people ask us over the years.

### **Can I migrate abroad with a visiting visa?**

No You Shouldn't. It is illegal to do so. Visiting or Tourist Visas are for not for residing. You will need a Work Permit or Permanent Residence to legally migrate abroad, which, in most cases, you can renew every 3 or 5 years, within the country of residence. To use visiting visa to reside illegally in a country would require you to hide away from authorities to avoid been deported and banned for life. It is not worth it. It's better to do the right thing.

### **What documents do I need for my processing?**

Typically, requirements differ based on what program you are applying for and the country. However, there are standard requirements for most countries which are listed below:

- ° International Passport Data page with a minimum of 2 years validity, ° C.V., ° Cover Letter,
- ° Optimized LinkedIn Profile, ° Academic & Vocational Credentials, ° IELTS (For Canada),
- ° Certificate Evaluation (For Canada), ° Proof Of Funds (POF), to mention a few.

### **How Long does it take to secure a Job Offer Overseas?**

Securing a Job offer depends on various factors which includes the type of Job, principal applicant's credentials, budget range, work experience, desired country, availability, and more. On the average, securing a Job offer in Europe, U.K and Australia takes between 1 to 6 months, In Canada could take between 2 to 12 months, and the U.S could take 3 to 10 months.

### **Can I pay for your services after the Job Offer is Obtained?**

No. We do not accept a pay after service option because we expend funds and other resources to secure your job offer and other related services.
